1. General Information

2. Application Rights and Method

Applications regarding the rights of data subjects deriving from the PDPA must be submitted to us in writing following Article 13 of the ("**PDPA**") or in any other manner to be determined by the Personal Data Protection Board ("**Board**").

In this context, applications to be made to our Company in writing can be forwarded to us by printing out this form, by the Applicant's application, by a notary public, or by sending it to the registered e-mail address of the Company by signing with the secure electronic signature defined in the Electronic Signature Act No. 5070 by the Applicant by e-mail sent from the e-mail address that the Applicant has previously notified to our Company and registered in our Company's system.
